COVID-19 POLICY @ DE CASTLE ROYAL

Buying a condo in Cambodia – what you need to know?

While there are many ways to acquire land or real estate as foreigners in Cambodia, condominiums are often the preferred way to own property. The acquisition of a condo in Cambodia will only be possible if the title deed is the right one, i.e. a strata

These property titles were introduced in 2009 in order to attract foreign investors and to respond to the increase in the existing expatriate population.

What are the conditions for obtaining a Strata?

Strata titles must meet main 4 conditions:

- Strata titles only apply to buildings constructed in
- Foreigners can only own up to 70% of the floor area
- Strata Titles cannot be issued to ground floor units.
- Strata Titles cannot be issued to any property within 30km of the nearest land border.

A QUICK GUIDE FOR FPCS REGIISTRATION @ DE CASTLE ROYAL

One such law is the new FPCS under Circular No. 028 of the Ministry of Interior, released in July 2019, which mandates all landlords and owners of residences to report the presence of foreigners residing in their properties through an online system known as FPCS (Foreigners Present in Cambodia System).

Base on their advice (immigration authorities) that all foreign nationals are not allowed to register by themselves, so they are required to come to management office to provide some personal document as followings:

- * Passport copied with valid VISA (both Co-owner & tenant)
- * Lease agreement copied (tenancy only)

Note: for any foreign national whose downloaded the FPCS apps then registered by themselves (for residents who are owned the units or leased @ De Castle Royal), it will be rejected by related authorities when they need to proceed any legal document which is required from the government.

MAINTENANCE & REPAIRS

- * Improved light view at G floor for more attractive.

- * Conducted vacuuming of both water supply tanks as every 6 months regular schedule basis.
- * Replaced board inverter & governor of elevators.
- * Rope of elevators (#2,3 &4) will be replaced base on the specific schedule_in processing

RUBBISH & FNVIRONMENT MANAGEMENT

* Keep good environment and prevent the smell of trash in the building is also the prioritized work to be focused, in case any resident drops outside of bin, we will inform them accordingly.

SAFFTY MANAGEMENT

- * Fire police inspected the fire system in the whole building as every 6 months regular schedule basis.
- * Invited fire police to conduct the training of fire fighting to all staffs in security (GSS) in the building.
- * Conducted the maintenance on the fire hydrant boxes as every 3 months and tested the fire pump system as regular schedule basis.

South Korea and Cambodia forge strategic partnership to boost ties

Agreements on defense, trade and infrastructure aim to expand cooperation between the two nations

South Korea and Cambodia agreed to establish a strategic partnership to expand cooperation in defense, trade and infrastructure during a summit between South Korean President Yoon Suk-yeol and Cambodian Prime Minister Hun Manet in Seoul on Thursday. The partnership includes plans for a South Korean naval vessel to call at a Cambodian port later this year and increased collaboration in peacekeeping operations and against transnational crimes.

The two leaders also signed agreements to boost economic ties through a bilateral free trade agreement and to promote cooperation in social, cultural and development sectors. South Korea will increase its loan to Cambodia from \$1.5 billion to \$3 billion through the Economic Development Cooperation Fund and extend the provision period from 2022 to 2026 to 2022 to 2030. The countries also reaffirmed their commitment to international peace, security, free trade and the rule of law.

The agreement to double South Korea's loan to Cambodia from \$1.5 billion to \$3 billion through the Economic Development Cooperation Fund will likely create new business opportunities for South Korean companies. For instance, South Korean companies may gain access to new business opportunities, such as infrastructure contracts. Additionally, the move will also likely strengthen bilateral ties and expand Seoul's economic and political influence in Southeast Asia.
